

RULES AND SPECIFICATIONS ROTARY DISTRICT 6420 AWARDS

ELIGIBILITY -- DISTRICT ROTARIAN OF THE YEAR

This award is presented to a member of any Rotary Club in District 6420 deemed to have made the most outstanding contributions to the ideals and goals of Rotary International during the past year, or throughout their Rotary career.

Rotarians eligible for the District Club Officer of the Year Award or the District New Rotarian of the Year Award, Past District Governors, and prior winners of the award are not eligible.

ELIGIBILITY -- DISTRICT CLUB OFFICER OF THE YEAR

This award is presented to the President, Secretary or Treasurer of any Rotary Club in District 6420 deemed to have shown exceptional leadership within his/her club.

Rotarians eligible for the District Rotarian of the Year Award or District New Rotarian of the Year Award, Past District Governors, and prior winners of the award are not eligible.

ELIGIBILITY -- DISTRICT NEW ROTARIAN OF THE YEAR

This award is presented to a member of any Rotary Club in District 6420 who has joined Rotary for the first time within the two years prior to March 1st of the judging year, and is deemed to have made the most outstanding contributions to the ideals and goals of Rotary International.

Returning members and honorary members are not eligible.

Rotarians eligible in this category are not eligible for the District Rotarian of the Year Award, or District Club Officer of the Year Award. Prior winners and members of the Public Relations Committee are not eligible for this award.

ELIGIBILITY -- SERVICE ABOVE SELF AWARD

This award is presented to any individual residing within District 6420 who is deemed to have contributed the most towards the ideals of Rotary International.

This award is open to non-Rotarians ONLY; current and former Rotarians are not eligible.

JUDGING PANEL

Judging will be conducted under the auspices of the District 6420 Public Relations Committee, which must convene a meeting for judging purposes between the annual Presidents Elect Training Seminar II and the District Conference during the judging year.

JUDGING PROCEDURES

Any Rotarian belonging to a club within District 6420 may submit the name of a nominee(s) for any of these awards. It must be submitted by way of an official entry form, to be provided by the District; all requested information must be provided.

The deadline for submission must be set between the annual Presidents Elect Training Seminar II and the District Conference.

All nominations must be submitted at, or prior to, the judging meeting of the Public Relations Committee. Nominations submitted after the judging meeting will NOT be considered.

The Public Relations Committee will review the nominations, and decide on which candidates they believe deserve the respective District Awards. A direct vote of the Committee on each category will determine the winner(s).

No member of the Committee may vote on an award involving a member of their home Rotary Club.

No member of the Committee participating in the vote is eligible for any of the District Awards.

After a final result for each Award is determined, the outcome will be reported to the District Governor. The Public Relations Committee Chair will certify the results.

Once the results of the vote are certified, the decision of the Judging Panel is FINAL.

PRIZES

Results will be announced during the annual District 6420 Conference; plaques or equivalent trophies will be presented to each recipient.

DISPOSITION OF MATERIALS

After the judging, the Public Relations Committee Chairperson will collect all scoresheets and ballots for safekeeping, until after the winners are announced at the District Conference.
